COMMON ORDER

Mr.A.P.Srinivas, learned Senior Panel Counsel, and

Mr.T.Nalinidhar, learned Junior Panel Counsel takes notice for the Respondents.



2. In all these Writ Petitions, the Petitioner has challenged the respective impugned Composite Order in Original No.60/2025 in GST-AC dated 27.11.2025 passed for the tax period between 2018 and 2025 .

3. In WP.No.12703 2026, Petitioner has also prayed additionally for a Mandamus to direct the respective Respondents therein namely the various Commissioners of Municipal Corporations to reimburse the tax and interest liability on account of the increase in the rate of tax from 12% to 18% vide Notification No.3/22–Central Tax (Rate) dated 13.07.2022 amending the Principal Notification No.11/2017 - Central Tax (Rate) dated 28.06.2017.

4. The case of the Petitioner is that the Petitioner cannot be mulcted with higher tax liability in respect of contracts signed prior to the above amendment.

5. That apart, it is submitted that the Petitioner has been denied Input Tax Credit on the input tax availed by the Petitioner contrary to the Section 17 of the respective GST Enactments.

6. It is submitted that the Petitioner is engaged in providing services which are not supplied within the meaning of Section 7 of the respective GST Enactments in the light of Schedule 3 to the respective GST Enactments.



7. Having considered the submissions made by the learned counsel for the Petitioner and learned Senior Panel Counsel, I am of the view that the Petitioner has no case for interfering with the respective impugned orders in original No. 60/2025-GST AC dated 27.11.2025 under Article 226 of the Constitution of India.

8. Neither any procedural irregularity is discernable nor any perversity is discernable from the reading of the impugned order. It cannot also be said that the impugned order has been passed in violation of principles of natural justice or that the conclusion arrived by the respondent while passing the impugned order suffers from arbitrariness. Therefore, I am not inclined to entertain these Writ Petitions. The limitation for filing an appeal before the Appellate Authority would have already expired. These Writ Petitions have been filed only after the expiry of the limitation .

9. Considering the same I am inclined to give liberty to the Petitioner to challenge the order before the Appellate Commissioner under Section 107 of the respective GST Enactments, within a period of 30 days from the date of receipt of a copy of this order. To that extent respective Writ Petitions are disposed of.

10. In so far as the other part of the prayer in WP.No.12703 of 2026 is



concerned, I see no harm in directing the respondent Nos.2 to 20, to dispose of the Petitioner's representation for reimbursement of the tax amount on account of the above enhancement in the rate of tax along with interest. These respondents shall consider the request of the Petitioner in disposing it on merits.

11. These Writ Petitions are disposed of with the above observations. No costs. Connected Miscellaneous Petitions are closed.

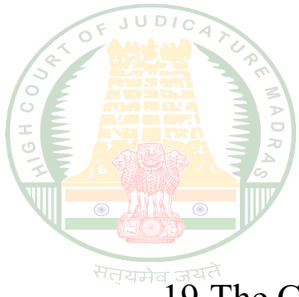

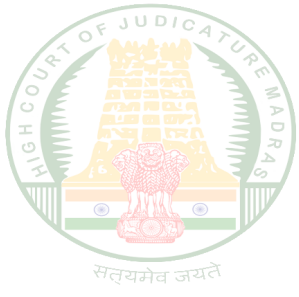
